

**LONDONDERRY TOWNSHIP BOARD OF SUPERVISOR'S REGULAR  
MEETING II  
Monday June 23, 2008**

Meeting II of the Londonderry Township (LDT) Board of Supervisors (BOS) was called to order at 7:31 PM by Supervisor-Vice Chairman Wayne Grover. Supervisors Wayne Grover and Midge Leitch were present.

**COMMENTS FROM THE PUBLIC:** There were no comments as there were no residents present when the BOS II meeting began. At the end of the meeting Supervisor Grover again asked for public comments and there were none.

**MINUTES OF June 10, 2008 BOS:** As the Minutes had previously been emailed to the BOS, read, reviewed, and all changes made, Wayne Grover made a motion to approve the Minutes of 06-10-2008 as written. Midge Leitch seconded the motion. The vote was unanimous.

**OLD BUSINESS:**

- A. STREAM SIGNAGE:** LDT was asked by the Southeastern Pennsylvania Resource Conservation and Development Council to participate in a Stream Signage Survey. Supervisor Leitch reported she has driven the LDT roadways and recorded all the streams and the bridges over the streams in LDT. None of the LDT streams currently have signs. She has submitted the survey and indicated our interest in the project with the understanding that this project may not be funded.
- B. COHEN EXTENSION:** The Planning Commission (PC), at its last meeting, recommended the BOS acknowledge the offer of a 90 day extension by Mr. Shimon Guy of Guy Engineering Associates, Inc. in a fax dated 06-04-2008 on behalf of his client, Mr. Sander Cohen. The extension is for 90 days from 07-02-2008 until September 29, 2008. Wayne Grover made a motion to acknowledge Mr. Cohen's offer of extension from 06-30-2008 to 09-29-2008. Midge Leitch seconded the motion. The vote was unanimous.
